## **G.N.S.R.A. COPYRIGHT OF DIGITAL IMAGES.**

1. Original 35mm slides, negatives and prints loaned to the G.N.S.R.A., after scanning will be copied into an equivalent digital file[=digital image]. The original material will be returned to their owner/depositor.
2. By loaning the original slides, negatives and prints the owner/depositor confirms the resulting digital files are gifted to the G.N.S.R.A. as an absolute and perpetual gift.
3. The resulting digital files will share their copyright equally with the owner/depositor and the G.N.S.R.A.
4. The owner /depositor will allow the G.N.S.R.A. to use the digital images in the pursuit of the associations aims as defined in the constitution. Joint copyright of the digital files will allow the G.N.S.R.A. to :
  - a. a-copy the files.
  - b. b-adapt the files.
  - c. c-publish the files in the association's "Review" magazine and other books it will occasionally publish. Such use will receive an acknowledgement/thanks within the text but no fee will be given.
  - d. d-provide the digital files to non G.N.S.R.A. magazines or books for publication. Any fee derived from these will be divided equally between the owner/depositor and the G.S.R.A..
  - e. e-lend the files for study.
  - f. f-communicate the files by electronic means e.g. placing them on the G.N.S.R.A. web site [see below].
5. If the digital file is used it will always show the name of the owner/depositor and G.N.S.R.A. beside a copyright mark.
6. Use of digital images on the G.N.S.R.A. web site will be at a resolution and size to permit reasonable quality for viewing when downloaded but insufficient to allow high quality copying.
7. The copyright agreement will last for at least 1 year and thereafter can be terminated with 4 weeks notice in writing by the owner/depositor or their representatives or the G.N S.R.A..
8. The agreement will remain in effect notwithstanding the death ,incapacity or resignation from the Association of the lender subject to clause 7 above.
